The fixed investment options do not incur any annual expenses.

Information about shareholder-type fees related to The Commodore Advantage is set out in the chart below Table 3. These fees are in addition to the total annual operating expenses of the Subaccounts. The Subaccounts, the Portfolios, and the fixed investment options do not charge any shareholder-type fees.
