The total annual operating expenses of a Subaccount are expenses that reduce its rate of return. Total annual operating expenses of each Subaccount include: (1) the total annual operating expenses of the underlying Portfolio; (2) a mortality and expense risk charge of **0.95%**; and (3) an administration charge of **0.15%**. The fixed investment options do not incur any annual expenses.

Information about shareholder-type fees related to The Commodore Spirit is set out in the chart below Table 3. These fees are in addition to the total annual operating expenses of the Subaccounts. The Subaccounts, the Portfolios, and the fixed investment options do not charge any shareholder-type fees. A summary of restrictions and limitations that apply to purchase payments, allocations, transfers, withdrawals, and active trading is set out in the chart below Table 3.

The cumulative effect of fees and expenses can substantially reduce the growth of retirement savings.
